SACRAMENTO REGIONAL TRANSIT DISTRICT BOARD OF DIRECTORS BOARD MEETING May 14, 2018

ROLL CALL: Roll Call was taken at 5:33 p.m. PRESENT: Directors Budge, Harris, Hume, Jennings, Miller, Morin, Nottoli, Schenirer, Serna and Chair Kennedy. Director Hansen arrived at 5:51.

PLEDGE OF ALLEGIANCE

PUBLIC ADDRESSES BOARD ON MATTERS NOT ON THE AGENDA

Barbara Stanton – Ms. Stanton would like to know if/when a report will be given on the Yolo County Bus bid submitted by SacRT, the cost, and outcome. Mr. Li indicated that Yolo County awarded the bid to their current provider.

Mike Barnbaum – Mr. Barnbaum was excited to hear that SacRT received grant funding. Mr. Barnbaum also provided information on others who received grant funding.

Felix Huerta* – Mr. Huerta indicated that he submitted a petition from the Operating Engineers Local Union No. 3 for certification and recognition for the Management Professional Employee Group on May 3. Mr. Huerta hopes the group will be allowed to unionize without fear of reprisal, intimidation, or threats. Mr. Huerta indicated it was his understanding that the Director of Labor Relations has sought to find out the organizers of this campaign. Mr. Huerta indicated that he is "here to tell you that if he touches one hair on that person's head, we are going to have a problem". Mr. Huerta stated that the group has a right to organize, without fear of retaliation, without interrogation. Mr. Huerta indicated that the State Mediation and Conciliation Services will determine the disposition of whether the group is an appropriate unit.

Brenda Anderson – Ms. Anderson wants to know about the transfer of authority from the Board to the General Manager/CEO, and the process of making this transfer (why and how).

Jeffery Tardaguila – Mr. Tardaguila reminded the Board of upcoming meetings in the region. Mr. Tardaguila thanked the Board for getting "some" of the display boards up, particularly at the Sacramento Valley Station. Mr. Tardaguila still has problems with the functionality of his Connect Card and believes this may be operator error in signing on to the system. Chair Kennedy indicated that Mr. Tardaguila could meet with Director Harris who is currently the Chair of the Sacramento Transportation Authority.

Arthur Ketterling – Mr. Ketterling wanted to know about the later service for Folsom. Mr. Li indicated that the later service will start on June 17th.

Director Budge and Schenirer thanked staff for offering this program.

ACTION: APPROVED - Director Schenirer moved; Director Budge seconded approval of the item as written. Director Schenirer requested that staff provide an analysis of the program to see if this is something SacRT might want to do in the future. Motion was carried by voice vote.

GENERAL MANAGER'S REPORT

Mr. Li thanked SacTRU for organizing a post card comment writing session during Earth Day; noted that he and Director Nottoli rode the light rail to Cordova Town Center for a meeting; and that he along with Directors Budge, Hume, Miller and Hansen attended Cap to Cap. SacRT has been recommended for two State grants: 1) \$64 million to begin SacRT's efforts to replace our existing light-rail fleet and conversion of

low-floor vehicles, funds for 20 vehicles and platform conversions at key stations and includes funds for three peak express trains in both directions to help reduce travel times and congestion, and 2) \$20 million to fund infrastructure track improvements to the Gold Line. These enhancements will allow for 15 minute service frequency to Folsom. In addition this morning, SacRT was awarded a planning grant for \$300,000 from Caltrans. On June 17, 2018, SacRT will formally launch extended hours on the Gold Line service to Historic Folsom. On Thursday, May 10, 2018, the Sacramento Transportation Authority voted to award \$12 million to SacRT for their neighborhood shuttle program. The funds will allow SacRT to expand on-demand transit service in additional communities through the region.

Mark Lonergan provided an update regarding the status of implementing strategies to address capacity issues on bus routes 51 and 82. Mr. Lonergan indicated that the real capacity issue is that of wheelchair capacity. Each bus has a maximum capacity to hold 2 wheelchairs at a time. After review of the statistics, wheelchair pass ups are 1% of SacRT's total ridership systemwide. One-half of the pass ups were related to the mix of ambulatory riders that have disabilities seated in the area designated for securing wheelchairs. As a short-term measure, operators will be reinstructed to ask patrons to move, if they can, further back in the bus into a seated area, allowing operators to free up the securement area. In the newer fleets of buses (Gillig), the areas are separated so that the wheelchair securement area is made just for wheelchairs, the next row back would is designated for others with disabilities. The ultimate solution would be to increase service; however, SacRT is unable to do so at this time, but will be looking at this during the SacRT Forward effort.

Director Nottoli indicated that SacRT has an easement (if not ownership of the property) that lies east along the Calvine corridor which was purchased to accommodate the light rail line at one time; staff will need to check on this easement. His concern is that if SacRT disposes of the subject property, SacRT might still have a remnant piece (easement or fee title) still remaining for long term maintenance. Staff should look at the multi-family development market rate for comparison. Staff should reach out to the Elk Grove Unified School District (EGUSD) to be sure they are aware of what Staff is doing, and whether they would have any use for any adjacent uses.

Chair Kennedy indicated that he had met with the potential developer who indicated they were in touch with the EGUSD.
