DISCUSSION

On March 13, 2017, the Board approved (Resolution No. 17-03-0029) the Personal Services Contracts (PSC) for the Security Operations Center (SOC) staff which includes 1 SOC Director, 2

SOC Sergeants, and 11 SOC Officers. Their contracts are set to expire on June 30, 2018 and SacRT is still in need of their services.

The SOC is responsible for monitoring more than 1,500 cameras on SacRT buses, light rail trains and stations and recovering footage from any incident that occurs in the system. Other responsibilities include running identity checks on individuals without photo identification, and generating calls for service. The SOC receives calls from members of the public on the crime tip hotlines and the SacRT mobile reporting app. This provides patrons with a way of reporting incidents on SacRT's system. The SOC staff will soon be responsible for monitoring the fare vending machine burglar and service alarms. SOC staff are not sworn law enforcement officers, but must pass a Sacramento Police Department (SPD) background check and be accepted and maintain an active status in the SPD Volunteer Program. The SOC is housed in the Sacramento Real Time Crime Center on 300 Richards Blvd and operates 24 hours a day, 7 days a week. This is a high-tech center that features an array of surveillance cameras throughout the City of Sacramento.

With SacRT's strong emphasis on safety and security, SacRT needs the services of 1 SOC Director, 2 SOC Sergeants, and 12 full-time SOC Officers (3 Officer positions are currently vacant) for minimum staffing. Some of the SOC Officers will work full-time and some will work part-time to help fill in the gaps in service when full-time officers are unavailable. Due to emergencies, special events and/or crime series, overtime is likely. The General Manager/CEO has authority to sign for vacant SOC Personal Service Contracts, so long as the contract term does not exceed 12 months and the total consideration does not exceed \$50,000 in compliance with Article 5.03 B of SacRT's Personnel Rules and Procedures. If the contract exceeds those parameters, SacRT staff must bring such future contracts to the Board for approval. Funding for these amendments is provided through the operating budget.

The FY2019 hourly rates for SOC staff are as follows. SOC Director Vitaliy Yakimchuk is \$26 per hour. SOC Lead Sergeant Robert Kerr is \$24 per hour. SOC Sergeant Daniel Cuevas is \$22 per hour. SOC Officers Yelena Bychkov, Maksim Kozlov, Antwan Pippins and Kim Staley are \$21 each per hour. SOC Officer Nathan Delgado is \$20 per hour. SOC Officers Julia Ann Fuller, Brendan Welsh, Cassaundra Shaffer and Tyler Ferrier are \$18 each per hour.

Under the direction of SacRT's Chief of Police Operations, Lisa Hinz, the SOC staff positions are described below:

SOC Director: Vitaliy Yakimchuk

The former SOC Director, Miguel Delgado, resigned in January 2018. Police Services interviewed for the vacant SOC Director position and concluded that SOC Sergeant, Yakimchuk, was the most qualified candidate for the job. The First Amendment to the Personal Services Contract for Temporary Employment with Yakimchuk as the SOC Director was executed on January 23, 2018. His hourly rate increased from \$21.00 to \$25.00 effective February 1, 2018.

The SOC Director job duties include, but are not limited to:

- Overseeing all of the assigned SOC Sergeants and Officers.
- Recruiting and training.
- Ensuring SOC staff are on-site, on time and performing their duties in a professional manner.
- Acting as a liaison between SOC staff and various SacRT departments.
- Handling complaints from SacRT staff and patrons regarding SOC staff conduct and job performance.
- Creating and updating SOC staff schedules.
- Completing payroll paperwork.
- Providing SacRT with a roster detailing SOC staff assignments, shifts, and weekly hours.
- Assigning equipment to SOC staff and ensuring proper maintenance and inventory of equipment and vehicles, including incidentals such as changing radio batteries.
- Providing proper written reports to RT when requested.
- Attending meetings with SacRT staff when requested.
- Performing independent and complex administrative work.
- Operating standard office equipment and computer software (including but not limited to Microsoft Word, Excel, and PowerPoint).
- Operating the Public Address (PA) system to make announcements related to public safety and security and for bus bridges in the system.
- Will soon be responsible for monitoring fare vending machine burglar and service alarms.
- Other duties as needed to ensure success of the SOC.

Staff recommends the approval of the Second Amendment to the Personal Services Contracts for Temporary Employment with Vitaliy Yakimchuk as the SOC Director, wherein the total consideration is increased by \$75,000 from \$66,667 to \$141,667, the hourly rate is increased from \$25 to \$26 an hour, the Scope of Work is modified to change the Temporary Employee's duties, and the term is extended to June 30, 2019.

SOC Sergeants: Daniel Cuevas and Robert Kerr

With Yakimchuk promoting to the SOC Director position, a SOC Sergeant position became vacant. Police Services interviewed for the vacant SOC Sergeant position and concluded that SOC Officer, Cuevas, was the most qualified candidate for the job. The First Amendment to the Personal Services Contract for Temporary Employment with Cuevas as the SOC Sergeant was executed on February 26, 2018. His hourly rate increased from \$20.00 to \$21.00 effective March 1, 2018.

The hourly rate for SOC Sergeant, Kerr, increased from \$21.00 to \$23.00 effective February 1, 2018 under a First Amendment due to his lead sergeant role at the SOC.

- Ensure SOC staff is trained on SacRT's Defensive Driving class and receives and maintains their California Law Enforcement Telecommunication System (CLETS) and is trained on SacPD's Emergency Vehicle Operations Course (EVOC).

SOC Officers: Yelena Bychkov, Nathan Delgado, Tyler Ferrier, Julia Anne Fuller, Maksim Kozlov, Antwan Pippins, Cassaundra Shaffer, Kim Staley, and Brendan Welsh

The SOC Officer job duties include but are not limited to:

- Operating two-way radio to communicate with SacRT staff, law enforcement officers, Sacramento Police Department (SPD) volunteers and guards.
- Using sound judgment and good verbal skills during routine and emergency situations and
 effectively communicating with persons who may be irate, under stress and/or difficult to
 understand.
- Retaining information regarding specific SacRT, SPD and SSD radio codes, elements of criminal offenses and having a working knowledge of all field operations within SacRT and local law enforcement agencies.
- Handling and screening incoming telephone calls from the AlertSacRT mobile reporting app which includes speaking with potential crime victims, witnesses and other SacRT patrons reporting similar problems. Coordinating the required response, in a timely manner.
- Providing records, warrants and other related information using local and state law enforcement databases.
- Keeping track of the location and status of the Police Officers and other units in the field.
- Recording all activity in a daily report.

- Using light rail station and train video surveillance equipment to search and identify system related problems, suspicious activity and/or terrorist threats.
- Coordinating and managing response efforts for high priority and emergency type of calls for service.
- Monitoring surveillance cameras.
- Coordinating the response of medical and other public safety units to emergencies or in progress calls for service.
- Entering calls for service, coordinating response of resources, maintaining status of personnel assigned to SacRT Police Services for safety and deployment purposes.
- Recording video from live train footage as requested and maintains accurate documentation of all recoded video.

- Will soon be responsible for monitoring fare vending machine burglar and service alarms.
- May perform any combination of the aforementioned duties and/or other related tasks at the same time.
- Other safety and security duties as required.

Under the General Manager/CEO's authority, SacRT entered into a PSC with Cassaundra Shaffer on July 24, 2017 and Tyler Ferrier on November 13, 2017 as SOC Officers. The total consideration of each contract is \$30,000 and \$29,000 respectively, with the same contract expiration date of June 30, 2018 as the other SOC Officers.

Staff recommends the approval of the First Amendment to the Personal Services Contracts for Temporary Employment with Cassaundra Shaffer as a SOC Officer, wherein the total consideration is increased by \$50,000 from \$30,000 to \$80,000, the hourly rate is increased by \$1.00 an hour from \$17 to \$18 an hour, the Scope of Work is modified to add duties to be performed, and the term is extended to June 30, 2019.
