Mr. Li invited everyone to participate in SacRT's brainstorm workshop to help set the design for the Dos Rios Station; recognized a number of SacRT employees for their long and dedicated service; provided an update from his trip to Washington D.C. for the APTA Legislative Conference and Finance Committee Budget meetings; and noted that while in D.C., President Trump signed a \$1.3 trillion federal spending bill; Mr. Li met with FTA Administrator, Jane Williams, and her leadership team; SacRT was awarded \$1.2 million in federal grant funding from the Department of Transportation which will go toward replacing and maintaining the CNG fueling equipment; and SacRT has started major camera and public address system upgrades at the Watt/I-80 and Watt West stations made possible by California Proposition 1B funds.

James Boyle provided an update on the Route Optimization Study now known as SacRT Forward; Mark Lonergan provided an update on Microtransit pilot program and Brent Bernegger provided an update on the February financial status and student fare ridership pilot program.

Director Schenirer asked staff to provide information relative to a dollar amount that would make the student fare break even so that SacRT does not lose money.

11. Information: Withdrawing Proposed Changes to Title III of the Sacramento Administrative Code Relating to the Board's Rules of Procedure (L. Ham)

Chair Kennedy noted that staff has been taking comments from the public and the Board members, and the Board is allowing staff more time, so staff will be coming back with another recommendation in the future, primarily looking at changing the Agenda as far as the order of business.

#### **PUBLIC HEARING**

#### **NEW BUSINESS**

12. Resolution: Authorizing Staff to Release the Sacramento Regional Transit District Preliminary FY 2019 Operating and Capital Budgets and Set Notice of a Public Hearing for May 14, 2018 (D. Goldman/B. Bernegger)

Brent Bernegger noted that there is a slight increase for the 2019 Operating budget of 2.6% increase. The majority of the capital budget program is based on new grant opportunities. There were no significant changes to any of the service levels and no change to the fare structure. Measure A makes up 26% of the operating revenues. SacRT only receives 1/6 of a cent (17%) of the total sales tax collected which is low compared to other transit agencies who have dedicated taxes or a much higher funding level.

ACTION: APPROVED - Director Nottoli moved; Director Hansen seconded approval of the item as written. Motion was carried by voice vote.

13. Information: Presentation on Shorter and Longer Term Concepts for Reimagining the Watt/I-80 Transit Center (J. Boyle/L. Ham)

Traci Canfield noted that SacRT received a Caltrans planning grant in order to engage the public and collect information on improvements that could be made at the Watt/I-80 transit center. The Watt/I-80 transit center is the biggest bus/light rail transfer center in SacRT's system in which 3,500 rider move throughout this center daily. During the outreach process, it was made clear by SacRT's passengers that they still rely on this facility despite the challenges of the facility. SacRT partnered with WalkSacramento who led the outreach effort for this study. Four concepts were created during the study; however, there was a clear message that short term improvements needed to be made immediately. Short term improvements included replacing the two elevators, providing more wayfinding and updated customer information, touch ups around the facility. adding more lighting, and look at restricting access to the alcoves and hidden spaces, particularly under the underpass. Longer term ideas were tearing down the existing structures and rebuilding them (stairwell and elevator structures) and opening up the facility getting rid of hiding places, adding lighting, widening the sidewalks, add a midblock crossing, and adding monument signs. All improvements will require partnerships with the County of Sacramento and Caltrans.

Next steps include pursing more funding for longer term improvements, and reviewing the results from the SacRT Forward project to see what is recommended for infrastructure needs on Watt Avenue, conducting environmental reviews and design for long term improvements, replacing the two elevators and budgeting for longer term improvements to include increasing maintenance at the facility, and maintaining the security coverage.

It is also important that SacRT work with its partners to identify strategies and resources to improve the neighborhood and continue to build upon the momentum that was April 9, 2018 Action Summary

developed. Discussions have already ensued with Mercy Housing and the Watt Avenue PBID about making improvements to the neighborhood.
