DISCUSSION

On September 10, 2018, the Board approved a sole source Contract with GreenPower Motor Company, Inc. for the purchase of six EV-STAR Electric Buses and charging equipment for an amount not to exceed \$582,000, plus applicable sales tax and fees, and delegated authority to the General Manager/CEO to execute the Contract.

When purchasing buses and other rolling stock, it is standard for SacRT to include in its contracts a requirement for bus manufacturers and/or authorized dealers to provide both performance and warranty bonds to protect SacRT's interests. When submitting its proposal to SacRT, GreenPower Motor Company, Inc. was unaware of the bonding provisions, and did not anticipate the additional expense. GreenPower Motor Company, Inc. also did not include the fees associated with training

REPEALING RESOLUTION NO. 18-09-0094, APPROVING A SOLE SOURCE PROCUREMENT, AND DELEGATING AUTHORITY TO THE GENERAL MANAGER/CEO TO EXECUTE A CONTRACT WITH GREENPOWER MOTOR COMPANY, INC. FOR THE PURCHASE OF SIX EV-STAR ELECTRIC BUSES TO OPERATE SMART RIDE SERVICE

WHEREAS, on September 10, 2018, the Board approved a sole source procurement and delegated authority to the General Manager/CEO to execute a Contract for purchase of six EV-STAR Electric Buses to GreenPower Motor Company, Inc.

WHEREAS, subsequent to the approval, GreenPower Motor Company, Inc. increased its price proposal to include the expense of purchasing performance and warranty bonds, and fees associated with training SacRT Bus Maintenance mechanics.

WHEREAS, the Board desires to approve a sole source procurement and delegate authority to the General Manger/CEO to execute a contract with the modified pricing.

WHEREAS, in accordance with Section 1.405 B.1 of the SacRT Procurement Ordinance, a sole source procurement for supplies is permitted upon a determination by the Board that the supplies can be provided only by one firm and that efforts to seek competition would be futile.

WHEREAS, GreenPower Motor Company, Inc. builds purpose-built battery electric buses.

WHEREAS, because GreenPower's buses are the only vehicles in this Gross Vehicle Weight Rating and 25' length offered that qualify for Hybrid and Zero-Emission Truck and Bus Voucher Incentive Project (HVIP) incentives, no other manufacturer can meet SacRT's needs.

BE IT HEREBY RESOLVED BY THE BOARD OF DIRECTORS OF THE SACRAMENTO REGIONAL TRANSIT DISTRICT AS FOLLOWS:

THAT, Resolution No. 18-09-0094 is hereby repealed.

THAT, the Board hereby determines that a sole source procurement with GreenPower is appropriate because the supplies can be provided only by one firm and efforts to seek competition would be futile.

THAT, the Board delegates authority to the General Manager/CEO to execute a Contract for purchase of Six EV-STAR Electric Buses by and between the Sacramento Regional Transit District (therein "SacRT") with GreenPower Motor Company, Inc. (therein
