- SUBJ: AUTHORIZING TRAVEL OUTSIDE THE UNITED STATES FOR HENRY LI, GENERAL MANAGER/CEO TO REPRESENT SACRT AT THE UITP GLOBAL PUBLIC TRANSPORT SUMMIT

RECOMMENDATION

Adopt the Attached Resolution.

RESULT OF RECOMMENDED ACTION

Adopting this Resolution will authorize travel outside the United State for Henry Li, General Manager/CEO to represent SacRT at the UITP Global Public Transport Summit in Barcelona Spain.

FISCAL IMPACT

The estimated travel cost is \$5,494, which covers all anticipated cost including airfare, lodging, meals, and registration. This estimated cost is comparable to the cost of traveling within the United States if traveling from Sacramento to a conference on the East Coast.

DISCUSSION

UITP, the International Association of Public Transport, is a passionate champion of sustainable urban mobility and the only worldwide network to bring together all public transport modes. It has 1,600 member entities access to 18,000 contacts from 99 countries. The members are public transport operators and authorities, policy decision makers, research institutes and the public transport supply and service industry.

UITP is internationally recognized for its work to advance sustainable urban mobility. As noted above, UITP is the only worldwide network to bring together all public transport stakeholders and all sustainable transport modes and provides an opportunity for discussions about the integration and coordination between the different modes.

The UITP Global Public Transport Summit is the world's biggest event of its kind. The immersive four-day experience combines a diverse program of world-class Congress sessions and an outstanding Exhibition full of the latest transport related innovations, solutions, and products.

The General Manager/CEO will have the opportunity to speak to the UITP Congress and represent SacRT as well as the American Public Transportation Association as an Executive Committee member and share SacRT's equity and social justice best practices, in front of over 2,700 Congress attendees from over 80 countries. This session is a chance to share SacRT's experiences, ambitious projects, ideas and learn from industry leaders about best practices at the world's biggest event dedicated to sustainable urban mobility.

SacRT will benefit from participation at UITP Global Public Transport Summit because many of the topics that will be highlighted at the summit are relevant to many of the projects and programs SacRT is currently progressing. The following topics will be discussed:

- Public transport and urban life
- Renewing the public transport experience with a greater customer focus
- Digital Transformation
- Decarbonisation and low emissions
- Resilient urban and public transport
- New normal
- Innovative products and services

Pursuant to Title IX of the SacRT Administrative Code - Travel Authorization, travel outside the United States must be approved by the Board in advance.

The travel request covers all anticipated expenses.

Staff recommends approval for Henry Li, General Manager/CEO to travel to Barcelona, Spain June 3 – June 8, 2023.
