While visiting different SacRT light rail stations that have the modified platforms, I have become anxious about observations and behaviors seen when people meet the cobblestones.

My growing concerns include both pedestrians and passengers in wheelchairs. Some aspects of the cobblestones technique are discomforting.

While at first glance they appear to have an intention of being a barrier, they're lately seen as an abrupt transition. For pedestrians I've seen it awkward and jarring to see them walk either on or off the platform in this area. (Heaven help those mortals addicted to looking down and only down at their cell phone screens instead of the road below and the road ahead.)

I also worry of difficulties if a wheelchair gets lodged within these cobblestones.

I have been thinking for a while what kind of indicator could be placed here to prevent people from crossing over the cobblestones or getting stuck in them. Alternately, what about placing a smooth transition and removing the temptation to jump?

I strongly support the choices enumerated here, a, b and c. Ramps provide a seamless glide. Railings indicate where not to cross and stop going astray.

I'm glad to see our newly appointed VP of Capital Programs addressing this as one of his first assignments. May Henry Ikwut-Ukwa have safe fun and enjoyment implementing this while being financially prudent!

Subject: Facilitate transfers at the Power Inn Station Relocation

This request and recommendation is to ease transfers between buses at the Power Inn Station. It's for Routes 26, 38, 81, 82 and 87 which were rerouted temporarily from the University/65th Street Station. Yes, SacRT does advise in an informative alert that delays will happen.

The problem I've seen more than once is that as one vehicle arrives at this lot, another departs simultaneously on a different route. Transfers are more difficult to execute at Power Inn.

One example I witnessed this Saturday afternoon occurred between a 38 East that entered at 4:16 while a 26 North exited at 4:17. As the 38 started parking, the 26 left. Any passengers wanting to transfer would have to wait 30 minutes. (And these 30 minutes stretch painfully long at the desolate Power Inn Station, no stores, no food nor drink in sight.)

Conversely, this transfer was easy at the previous University/65th Street setup. The 38 was scheduled to enter at 4:10 and the 26 exited at 4:17. A 7-minute margin was comfortable.

Therefore my suggestion is this: could bus drivers who are about to depart Power Inn Station be instructed to look 2-3 minutes in advance for another bus that's arriving? If they see one, can they wait until that bus unloads passengers to see if any need to transfer to theirs? They can depart confidently thereafter.

Hopefully this procedure is easy to communicate and implement.

Sacramento Transit Advocates and Riders (STAR) is extremely concerned about the possible loss of the Dos Rios Light Rail Station.

The Mirasol Village development was premised on having light rail service for residents to access jobs and other destinations throughout the region. We feel that a promise was made to the residents that would be broken if the light rail station is not constructed. Without light rail service Mirasol and all housing in the River District will be isolated from opportunities outside. This cannot be mitigated by improvement to bus service.

Of the three options to be presented to the board by staff, option three is **unacceptable**. "Move forward with the substitute project, which includes the implementation of robust bus service, including augmentation of Route 33 and potentially other routes in the Project Area with zero emission, frequent service; while continuing to pursue new grant funding for the station in the future." Given that transit funding is at an historical peak that may not be seen again, indefinite delay of the station is likely to mean it will never be built.

STAR does not have a preference between options one and two.

The alternatives presented by SacRT, and the additional alternatives that have been discussed by the SIMPL Leadership Council and the community are all good ideas that deserve consideration and support in the future. However, they do not and cannot take the place of a light rail station. Mirasol Village deserves the light rail station, and so do transit riders and citizens of the SacRT service area.

As a result, the project now has a \$19 million funding gap and is in danger of losing \$20 million in grants because of delays in meeting project milestones, most importantly the release of bids in Dec 2023 and start of construction in 2024. In the face of state agency threats to pull all funding and redirect to other projects elsewhere in California, Senator Angelique Ashby convened a meeting of state, local, and federal officials, and community stakeholders on November 2, 2023, to develop a viable solution for Dos Rios station so that SacRT can retain the project's grant funding and build the

station pursuant to a revised schedule and budget, which is reflected in Option 1 in the SacRT staff report. Thanks to Senator Ashby's leadership, a consensus was reached among everyone present, including the representatives from the Governor's office, that so long as SacRT keeps to the revised schedule and budget, the state funding will be secure. However, the state officials also warned that if there were any further delays, particularly with SacRT Board approval in November and release of construction bids in December, then state funding would be pulled.

Fortunately, as described in Option 1, the \$19 million funding gap can be closed through an initial \$10 million SACOG allocation to SacRT from SB 125 funds, which SACOG CEO James Corless has committed to bringing to the SACOG Board for approval as soon as possible, and a commitment from SacRT to fund the balance. Note that RT's additional \$9M commitment would mainly go towards funding risk and contingency built into the budget and would leverage over \$30 million in other state and federal matching funds, which would still make the project among the largest transportation project beneficiaries of state and local matching funds in terms of ratio to local match in the region. Making matters even more compelling, if SacRT can find ways to reduce the construction costs below its current \$43M estimate, e.g., through value engineering, bid negotiations, project management, or otherwise, its investment would be reduced dollar for dollar by the amount of cost reductions.

In conclusion, no other scenario besides Option 1 would satisfy the commitments made to SGC and the Governor's office at Senator Ashby's meeting on November 3, and ensure the construction of the station that is so vital not only to Mirasol Village and Alchemist Public Market, but several other housing and mixed-use development projects that are either under construction or proposed for the immediate area, the Grower's District, and the River District at large. We therefore urge you to approve a resolution endorsing Option 1. We also stand willing to work with SacRT to request commitments from the City of Sacramento and other local partners to contribute towards the funding gap if necessary based on the construction bid process.

Since the inception of the Sacramento Regional Transit (RT) light rail system the Dos Rio Station was part of the vision for a completed service delivery to the central city. For many years this station was not on a RT highest priority list, because the location did not offer the greatest return on the investment.

In 2015 the US Department of Housing and Urban Development (HUD) awarded the Housing Authority of the County of Sacramento (HACOS), as lead applicant, and the City of Sacramento, as co-applicant, a \$30 million Choice Neighborhoods Implementation (CNI) grant to implement the Twin Rivers-River District/Railyards Neighborhood Transformation Plan and the Mirasol Village (formerly Twin Rivers) Transit Oriented Development and Light Rail Station project.

The CNI objectives are to create a sustainably built community, to increase housing types and transit growth to promote livability and connectivity within the River District promise zone. This award was designed to change the lives and create a brighter future for new and existing residents living in Mirasol Village, and the revitalizing surrounding neighborhoods. The construction of the Dos Rios Light Rail Station aligns with our goal to increase connectivity in the area and SacRT's goal to reduce carbon emissions. Dear Councilmember Valenzuela,

Thank you for the invitation to Sacramento Regional Transit's Board Meeting to discuss its proposed response to our September 20 communication.

Our team has worked diligently with Sacramento Housing and Redevelopment Agency (SHRA) and SacRT throughout the grant term to strategize and support the currently approved project. SGC supported and, at SacRT's request, executed an amendment to the grant agreement in May 2022 to extend project delivery timelines. After conducting multiple meetings with SacRT and SHRA this past year, we issued a Stop work order and the first formal Nonperformance Letter. The response letter on 08/29/23 from SHRA & SacRT, did not adequately address the funding deficit and showed a \$9.2 million funding gap with proposed corrective actions to secure additional funding. It also proposed to complete the project in 2028 (after the grants funds liquidate June 2027) and demonstrated continued uncertainty and risks as a result of soil contamination as well as likely increased costs. The nonperformance response and corrective actions were deemed insufficient on 09/23/23.

SGC also participated in a meeting called by Senator Ashby to discuss the project with all the project partners. Upon the meeting closure, there were agreements from SHRA and SacRT to move forward with a revised timeline and budget to deliver the Dos Rios Light Rail station.

As a reminder, SHRA must submit an amended corrective action plan and prepare a draft amendment request consistent with the corrective action plan no later than December 1, 2023, including a project justification and narrative, a revised detailed budget and work plan, and a description of the community engagement and decision-making process. We welcome the opportunity to review and coordinate with all relevant state agency partners once we receive a Corrective Action Plan. For a proposed alternative to be an acceptable alternative that would be fundable under an amended grant agreement, SGC will need to work with state agency partners to ensure the project's overall compliance with the Transformative Climate Communities program's funding requirements, including expenditure deadlines, community engagement, and adherence to greenhouse gas reductions.

SGC remains committed to the successful implementation of the Sacramento Integrated Multimodal Place-based Living Project and to the community in the project area. We will continue to demonstrate that commitment through a prompt review of Sacramento Housing and Redevelopment Agency's Corrective Action Plans and our continued emphasis on decision-making informed by the SIMPL project's Collaborative Stakeholder structure.
