I'm a transit rider and SacRT advocate and wanted to express my experience with 81. I do not own a car, and 81 is the closest line to my home. Its location is convenient, and it connects countless people to light rail stations and other buses so we can navigate the city.

Unfortunately, the bus only arrives every 30 minutes. While that may sound like frequent enough service, this severely impacts travel plans if a bus comes a few minutes early, or if a crossing signal does not change in time, you watch the bus pass your stop. 81 was expected to increase frequency to every 15 minutes a few years ago. This was exciting to hear, as 15-minute service would significantly increase the ability to take transit. Sadly, this expansion was tabled.

More morning and evening trips were planned for 81. This would improve mobility earlier in the morning and allows people to stay downtown at events or with friends until 8:30PM on Saturdays without worrying how they will get home. These services would significantly improve the lives of transit riders.

Everyone needs to travel, and SacRT is a lifeline for many people. Transit is even more important because biking and walking in Sacramento is extremely deadly. Transit is the only safe option.

Bus schedules need to reflect real life circumstances including traveling later on Saturday, frequent headways, and reliable service.

Seeing the proposed service for 81 removed yet again is deeply disappointing. Please consider improving this vital line.
