This grew after our 10/10/24 SmaRT Ride virtual workshop. Inspirations arise from

- 1 Anthony Adams and availability of options,
- 2 Henry Li and transitioning the general public
- 3 Two dates featuring Patrick Kennedy:
- -- 9/23/24 explaining SmaRT Ride's original purpose to fill system gaps
- -- 8/9/24 wine tasting with Transit Unplugged's Paul Comfort, including Chardonnay

The thrust here is continuously building community support for transit, with SacRT as the solutions provider for all.

Suggested is elimination of the word "Elimination."

Since Thursday I've thought of other industries where changes in product or service offerings were inevitable, and we still wanted to retain and even acquire more customers.

From SB125 then comes WB375, Wine Budgeting with smaller bottles.

Picture a wine bar struggling alongside today's ailing California wineries. Like shifting from \$8.4M to \$800K, WB375 compliance necessitates curtailing \$84 Chardonnay.

Let's pretend our wine enthusiast visits again and asks for his favorite.

We could say, "Your Chardonnay was eliminated."

Or we could say, "We know you enjoy white wine, so please sample our *reliable* Riesling and Sauvignon Blanc."

The drive, the emphasis is generating solutions. Instead of feeling inconvenienced, our customer appreciates our accommodation. We will be transparent when asked about circumstances, yet he may be more absorbed in these viable selections.

In addition to the 3-4 segments the next phase is targeting, we have a very substantial customer base, the general public. SmaRT Ride occasionally helped them. SacRT can prosper in any economic situation by repeatedly presenting up front its *existing blend* of the Sacramento Region's mobility and transit solutions.
