## DISCUSSION

The California Department of Transportation (Caltrans) will be adding a bus/carpool lane in both directions on Highway 50 (US 50) from Sunrise Boulevard to Watt Avenue. The US 50 West Citrus Overhead (bridge), which is located west of Sunrise Boulevard and passes over the intersection of Kilgore Road and Folsom Boulevard, will be widened on both sides by approximately 25 feet. Caltrans obtained a Construction and Maintenance Agreement with Southern Pacific (SP) in 1970 for the overcrossing. The Sacramento-Placerville Transportation Corridor - Joint Powers Authority (SPTC-JPA) and RT are successor in interest to SP.

On September 14, 2009, the Board of Directors approved a Supplemental Construction and Maintenance Agreement with Caltrans to formalize the addition to the original structure (maintenance, insurance, etc.) and provide for RT to undertake modifications to its overhead contact system (OCS) to accommodate the bridge-widening work. The Supplemental Construction and Maintenance Agreement provides RT to be fully reimbursed for all costs associated with the Caltrans project, including design, construction support and safety costs. parties originally contemplated that RT would hire a contractor to perform the OCS modification work.

Due to RT's need to competitively bid the OCS modification work, the work cannot be completed by Caltrans' desired date of April 30, 2010. RT has agreed to allow Caltrans to directly hire an RT-approved OCS contractor to complete the OCS work. The purpose of this Amendment is to redefine the terms and conditions stated in the Agreement to allow the RT OCS to be relocated by Caltrans in accordance with the design developed by RT and with RT oversight. RT will still receive full reimbursement for all costs it incurs in connection with the OCS modifications.

Staff recommends the Board approve the first amendment to the Construction and Maintenance Agreement US Highway 50/West Citrus Overhead with Caltrans to allow Caltrans to directly hire an RT-approved OCS contractor.
