## DISCUSSION

On January 11, 2010, the RT Board of Directors approved the release of an Invitation to Bid (ITB) for Roll Off and Front Load Waste and Recycling Containers Rental and Service for a 3-year period with the option to renew for two 1-year periods. Bidders could place bids on any or all of the following bid alternatives: 1) Alternative A, waste only 2) Alternative B, recycling only, or 3) Alternative C, waste and recycling. Alternative C was to be bid on an "All or None" basis, a conditional bid that requires the purchase of all services on which bids are offered and bidder declines to accept award on individual services. On January 27, 2010 the bids were advertised in publications of general circulation, posted on RT's website under Contracting Opportunities and mailed to qualified firms.

Subject: Awarding a contract to Allied Waste Services of North America, LLC for Roll Off and Front Load Waste and Recycling Containers Rental and Service

On March 9, 2010, bids were received from Allied Waste Services of North America, USA Waste of California, and Atlas Disposal. Their bids for the 3 base years of the contract are as follows:

Alternative A Bid Amount	\$139,544.52	\$158,922.40	\$191,243.10
Alternative B Bid Amount	\$1,888.60	No Bid	\$12,128.69
Alternative C Bid Amount	\$141,428.83	No Bid	No Bid

During the review of the bids, Sacramento Regional Transit District (RT) Procurement staff discovered that all of the bids contained mathematical errors. In accordance with the ITB, General Conditions and Instruction to Bidders, Article 1.10 Mathematical Errors, staff corrected the computations by multiplying the item price by the quantity for that item. Correcting the mathematical errors did not change the position of the apparent low bidder. Staff determined that Allied Waste Services of North America (Allied Waste) is the lowest responsive bidder. A Notice of Intent to Award Contract was issued to Allied Waste on March 30, 2010.
