**ACTION: APPROVED - Director Pannell moved; Director Hume seconded approval of the consent calendar with the exception of items 7 and 15. Motion was carried by voice vote. Absent: Directors Ashby and Fong.**

Director Pannell asked staff to update the Board on what has been happening with PG&E. Diane Nakano indicated that RT staff has been working with PG&E staff regarding the suggested relocation of the gas line along Detroit Blvd. PG&E staff has not been able to get back to RT with a confirmation, other than to say it looks promising to them, but they still need some technical information.

Director MacGlashan noted an error on page 4 of the issue paper. The "Excess Flood" section reads "The current crime program is with Travelers. Staff recommends that the coverage remain with Chubb for a program identical to last year's program." The correct language should read, "The current excess flood program is with Travelers. Staff recommends that the coverage remain with Travelers for a program identical to

last year's program" as reflected in the Program Cost Comparison table below the "Excess Flood" paragraph.

Mike Wiley noted that since 2008, RT has reduced its cost for the entire insurance program by \$500,000 per year, and from last year to this year, RT is showing a reduction of \$100,000 from fiscal year 2011 to fiscal year 2012.

Mike Wiley noted that after the issue paper was produced, the Department of Transportation issued funding levels for fiscal year 2011. RT received the full amount that was expected for our bus preventative maintenance and ADA complementary services at \$16.28 million and \$1.2 million, respectively. RT received an increase in funds for preventative maintenance for fixed guideway by \$826,000 beyond what was anticipated in the current fiscal year.

At the State level, AB 716 (Dickinson) which continues RT's exclusion policy, extended and updated, has now passed the Assembly with a vote of 58 to 8. This measure will now move on to the Senate for their consideration.

Mike Wiley then verbalized the rest of his written report.

19. Proposed Short Range Transit Plan Update (Covington)

- A. Accept Public Comment on the Short Range Transit Plan (S RTP)

RoseMary Covington indicated that she had only received comments thus far from SACOG.

The following members of the public commented on the S RTP. Their verbatim statements were recorded by a court reporter.

Jeffery Tardaguila - Mr. Tardaguila considers the S RTP to be a tactical report for a sales pitch for a half percent sales tax.

Mike Barnbaum - Mr. Barnbaum recommends that the once a year major changes be considered for January.

Beth Barker-Hidalgo - Ms. Barker-Hidalgo noted that it is the opinion of Paratransit staff that RT has underestimated future ADA demand.

Leoma Lee - Ms. Lee wanted to know that if RT was not getting funds from the State or Federal government, whether or not they had any other possible sources of income, other than raising the sales tax?

***ACTION: Director Cohn moved; Director Serna seconded the motion to continue the public hearing to June 27, 2011. Motion was carried by voice vote. Absent: Directors Ashby, Fong and Morin.***

The following members of the public commented on the SRTP. Their verbatim statements were recorded by a court reporter.

Leoma Lee - Ms. Lee wanted to know if RT was considering a fare increase.

Mike Barnbaum - Disappointed that the only service expansion planned is the Green Line to the River District. Mr. Barnbaum proposes the restoration of night light rail and bus service including weekend light rail service until 11:00 p.m., but during daylight hours maintain the existing 30 minute frequency. He suggested that any route providing service to the Los Rios Community Colleges (4 of them with their satellite campuses), Sacramento State, McGeorge School of Law and UC Davis extensions be served. He wanted to know what the cost would be associated with the bus and light rail service as he is suggesting.

Chair Nottoli requested that staff provide a cost estimate for Mr. Barnbaum's suggestion.

***ACTION: APPROVED - Director Pannell moved; Director Hume seconded the continuation of the public hearing to the June 27, 2011 Board meeting. Motion was carried by voice vote. Absent: Directors Ashby, Fong and Morin.***

21. Sacramento-Placerville Joint Powers Authority - Meeting of May 2, 2011

No additional comments were provided by Chair Nottoli or Director Sander.

**PUBLIC ADDRESSES THE BOARD ON MATTERS NOT ON THE AGENDA**

Speakers:

Joseph Asher - Mr. Asher believes that RT should have increased service by 100% back in June instead of cutting it, and believes that RT could have done this with only a 40% increase in expenses. He believes that the focus on light rail needs to change.

Donna Watson - Ms. Watson stated that she has noticed an increase in operator rudeness, operators departing before passengers are seated, and operators driving past riders at stops. Ms. Watson believes that RT needs to post signs in the buses asking parents to watch their children while on the bus, but realizes that parents are ultimately responsible for their children. Ms. Watson indicated that she sees people smoking at bus stops and in light rail stations, and that the stops and stations are not

clean. She noted that it is difficult for her to take night classes because she lives in Natomas and needs transit service to be extended to get her degree.

Eric Woodward - Mr. Woodward indicated that since the quantity/quality of the service dropped, the ridership dropped. Mr. Woodward believes that RT needs to “tap into different markets”. He suggested that RT revise their schedules to meet timed transfer points and make the service more efficient. Mr. Woodward indicated that there are many routes that the drivers have a lot of time between each run which should be used to provide additional trips.

Jeffery Tardaguila - Mr. Tardaguila indicated that May is bicycle month and suggested that RT increase their capacity of bicycles on buses when they order new buses and consider a redesign of the interior of the bus. Mr. Tardaguila indicated that Los Rios makes up 13% and does not have any representation.
