#### RECOMMENDATION

Adopt the Attached Resolution.

#### RESULT OF RECOMMENDED ACTION

Approving the Fifth Amendment to the Contract for General Engineering Support Services – 2020 with Mark Thomas & Company, Inc. ("Mark Thomas GESS – 2020 Contract"), will allow for timely execution of multiple Work Orders/Work Order amendments, allow SacRT to move forward with the Dos Rios Station Project and the Watt Avenue/Interstate 80 Transit Center Improvement Project, and ensure continuity of design services for additional projects. Approving Work Order No. 7.4 will restore funding to the Work Order for design support during construction of the Dos Rios Station that was previously approved by the Board.

#### **FISCAL IMPACT**

The Mark Thomas GESS – 2020 Contract was awarded in 2020 (Resolution No. 20-09-0089) with a Total Consideration amount of \$3,000,000.00. The Third Amendment to the Contract increased the Total Consideration by \$1,000,000.00, to \$4,000,000.00 (Resolution No. 2023-06-067). Funds are encumbered and applied against the Total Consideration for specific projects as Work Orders are issued.

To date, 24 Work Orders (some of which have been amended) have been issued under the Contract. When the Board was asked to approve Work Order No. 7.2 in March (for design support during construction of the Dos Rios Station project), that action inadvertently put the value of all Work Orders above the maximum total consideration amount, to \$4,582,679.21, although the costs actually incurred and invoiced remain well below that amount.

After this issue was identified, Staff issued Work Order No. 7.3 to reduce the maximum allowable total consideration for design support for the Dos Rios Station project and bring the total for all issued Work Orders under the maximum total consideration amount. However, there is a continuing need for design support services for the Dos Rios Station

project. In addition, Work Order No. 25 for \$45,483.91 for required bridge inspections is pending and further Work Orders may be required prior to the Contract expiration in September 2025.

Staff is therefore requesting that an additional \$1,000,000.00 be added to the Contract Total Consideration (through the Fifth Amendment) to allow for continued services until the end of the Contract term. The funding sources will be identified for each individual Work Order as it is approved by the General Manager or Board, as applicable.

In addition, Staff is requesting that the Board approve Work Order No. 7.4 to restore the required funding for design support during construction of the Dos Rios project. The funds for this Work Order amendment (\$592,810.71) were already budgeted and the expenditure was approved by the Board in March with the approval of Work Order No. 7.2.

#### DISCUSSION

The base term of the Mark Thomas GESS - 2020 Contract was extended by two years as part of the Third Amendment and will expire September 20, 2025. Increasing the maximum total consideration and approving Work Order No. 7.4 will allow for new Work Orders to be issued and existing Work Orders to be amended through the end of the Contract term to provide needed engineering support.

#### RECOMMENDATION

#### RESULT OF RECOMMENDED ACTION

Approving Amendment No. 2 to Work Order No. 5 to the Contract for On-Call Flagging Support Services will provide additional funding and extend the duration of work to allow National Railroad Safety Services, Inc. (NRSS) to provide additional flagging support during the construction of the Dos Rios Light Rail Station Project (Project) by DMZ Builders (DMZ) through July 3, 2025, by which time it is anticipated that the Transit and Intercity Rail Capital Program (TIRCP) funds will be available to fund Work Order No. 6 and Work Order No. 6 will be executed.

#### FISCAL IMPACT

Amendment No. 2 to Work Order No. 5 will increase the Work Order not-to-exceed for flagging support during construction of the Project by \$159,390, from \$145,222 to \$304,612. This amendment is fully funded through State funds.

#### DISCUSSION

SacRT is required by the Public Utilities Commission (General Order 175-A) to provide roadway worker protection, also known as railroad flagging, to support all activities in the SacRT rail right-of-way and infrastructure and systems. Under normal circumstances, the SacRT Light Rail Maintenance Department provides these services. However, at times the demand for railroad flagging exceeds the capacity of the department's personnel resources. To alleviate this problem, SacRT solicited bids from third party contractors to provide flagging services under a general On-Call Flagging Support Services Contract.

On December 11, 2023, the Board awarded three on-call contracts for railroad flagging support services for ongoing SacRT construction projects and third parties requesting access to SacRT's right-of-way, including a contract with NRSS.

The Dos Rios Light Rail Station construction contractor, DMZ, requires flagging services to construct the new tracks and light rail station. Due to SacRT's limited internal resources and its own ongoing maintenance obligations, the SacRT Light Rail Maintenance Department is unable to provide the required flagging services internally and requested assistance from NRSS.

On December 3, 2024, Work Order No. 5 was executed by the General Manager in the amount of \$145,222 for NRSS to provide flagging support through January 31, 2025 for the construction of the Project. On February 4, 2025, Amendment No. 1 to Work Order No. 5 was executed to extend the performance of work to March 31, 2025.

On February 10, 2025, the Board conditionally delegated authority to the General Manager/CEO to approve and execute Work Order No. 6 for flagging support services for the construction of the Project once the State of California (State) releases the TIRCP funds to SacRT (Resolution No. 2025-02-012). To date, the State has not released the TIRCP funds.

Under Amendment No. 2 to Work Order No. 5, NRSS will provide additional flagging support for the Project until July 3, 2025. The additional funding is anticipated to be sufficient to provide all required flagging support until TIRCP funds are released and Work Order No. 6 is executed. But if additional time or funds are still required before the release of TIRCP funds, an additional amendment may need to be processed at a later date.

ACCOUNT-BASED TRANSIT PAYMENT PLATFORM WITH

MASABI, LLC

#### **RECOMMENDATION**

Adopt the Attached Resolution.

#### RESULT OF RECOMMENDED ACTION

The proposed Resolution will conditionally approve a Contract for Account-Based Transit Payment Platform (Platform) with Masabi, LLC (Masabi) that will allow SacRT and other regional transit agencies, to move forward with a long-term contactless fare payment system.

#### FISCAL IMPACT

The proposed implementation fees of \$336,118.80 will be funded by a Transit and Intercity Rail Capital Program (TIRCP) grant and will not impact the Operations budget.

The first annual fixed fee will be \$153,972.96. plus an applicable Consumer Price Index (CPI) increase calculated at the time the payment is due, which will be at full system acceptance. These fees will further escalate annually in line with CPI adjustments. The fixed fees will be due in full annually in advance.

The intent is that the other regional transit agencies will pay a portion of these fees; however, if other Transit Partners choose not to participate (either initially or at a later point in time), SacRT will be fully financially liable for all costs associated with this Contract.

In addition to the fixed annual fees, SacRT (and the Transit Partners) will pay transaction fees for each ticket or pass processed through the Platform as shown in Table 3 below. Based on the invoicing and payment timeline for these fees, SacRT will likely be responsible for paying the fees on behalf of the Transit Partners and then seeking reimbursement.

It is important to note that the proposed FY2026 budget includes mobile application (currently ZipPass) fees sufficient to cover any transactional fees that may be incurred in FY 2026 as well.

The initial term of the Contract will be for 5 years, with a SacRT option to extend for up to 2 additional 1-year terms. While SacRT typically has the right to terminate contracts for convenience without penalty, the negotiated terms of this Contract will require SacRT to pay a penalty of up to \$450,000.00 for an early termination for convenience.

#### DISCUSSION

SacRT, El Dorado Transit, Placer County Transit, Roseville Transit, South County Transit/Link (SCT), Yolo County Transportation, and Yuba-Sutter Transit (collectively, "Transit Partners") previously issued a request for a Best and Final Offer ("BAFO") under the California Master Service Agreements for Contactless Payment Provision: Categories A (Payment Acceptance Devices) and B (Transit Processor Services) and have proceeded with award of contracts for those goods and services to Kuba, Inc. and Littlepay, Inc., respectively. SacRT launched these contactless services on April 1, 2025.

The "Platform" will provide electronic ticketing options to the customers of the Transit Partners with a specific focus on market segments, fare products, and payment methods that are not sufficiently covered by the contactless card (pre-paid, debit, and credit) payment option. The Platform will ultimately integrate with the contactless payment validators.

A Request for Proposals was issued on April 15, 2024, and SacRT received six proposals in July 2024. Staff reviewed and evaluated each proposal individually and invited the three top-ranked proposers to provide demonstrations of their product to further assess their ability to meet SacRT's needs. Based on the provided proposals and subsequent demonstrations, Masabi was deemed the most qualified proposer to provide the Platform. Staff has engaged in negotiations with Masabi over the last six months to finalize the Contract terms and conditions and fees.

The negotiations have concluded, and Staff has determined that the pricing offered by Masabi, including for the optional items, is fair and reasonable by comparison to other proposals.

Masabi's "Just Ride" fare payment platform provides passengers with a world class experience. Combining fare payment, trip planning, rider alerts, and enhanced messaging, among other features, passengers will no longer have to carry smart cards in their wallet or manage multiple online accounts to enjoy SacRT's and its regional partners' services. SacRT envisions the new Platform from Masabi to be a one-stop fare payment and trip planning shop for nearly all SacRT riders.

The Platform will be rolled out in multiple phases to provide a smooth transition for customers. The first phase of the project will introduce the new consolidated mobile fare payment application for SacRT and Yolobus passengers (Yolobus also currently uses ZipPass application). During this phase, SacRT and Yolobus passengers will download the new mobile application (yet to be named) and be able to enjoy the features provided within the base mobile ticketing application, including but not limited to, fare payment and trip planning. Tickets and passes will be validated visually during this implementation phase, similar to SacRT's current mobile app, ZipPass. However, additional features

included in the new mobile application will greatly increase the reach of the application to include riders receiving third-party subsidies that were unable to easily integrate into ZipPass.

State employees, college students and recipients of benefits from some social service agencies, among others, will all have access to SacRT fares on their mobile device for the first time without having to go through cumbersome processes to receive reimbursement. SacRT anticipates that Phase 1 of the project for SacRT and Yolobus will be completed by October 30, 2025. As the new mobile application is released to the public, SacRT will ensure that existing passengers using the current mobile application are notified to facilitate a smooth transition.

Passengers will also be able to add fare to the mobile application through a third-party retail network to be established by Masabi, creating additional options for passengers to convert cash to mobile fares.

Phase 2 of the project will integrate the new mobile application with the Kuba hardware (Tap2Ride system) installed on SacRT's bus and SacRT GO fleet. Mobile application users will electronically validate their tickets and passes directly on the Kuba hardware. Electronic validation will provide both SacRT and its passengers with even more benefits, including faster boarding times with little-to-no operator interaction, improved data location, and reduction in potential fraud. Phase 2 of the project (for SacRT) is scheduled to conclude April 30, 2026.

The other Transit Partners will be implemented in phases, beginning after SacRT, starting in summer 2026. Assuming all Transit Partners choose to participate, full system acceptance for all Transit Partners is anticipated by October 30, 2026.

Additional Contract options include: (1) integration of closed loop cards, which would provide a more direct replacement for the Connect Card system, (2) more in-depth integrations with the back office of the open loop fare system supported by Cal-ITP, (3) distance-based fares, and (4) customer rewards programs. Staff would return to the Board to exercise desired options if funding is available and a clear need and/or benefit to the region's passengers is presented.

Acting on behalf of the Transit Partners, SacRT will enter into the Contract with Masabi and subsequently enter into cost-sharing agreements with each of the other Transit Partners. Masabi's proposal includes one-time implementation fees (funded by a TIRCP grant), fixed annual fees, and transaction fees. The fixed annual fees and transaction fees will be shared with participating Transit Partners, with the allocation model still to be negotiated. If agreement is not reached, SacRT will remain responsible for these costs. Tables 1-3 below display the fee structure included in the Contract:

#### FISCAL IMPACT

No fiscal impact as a result of this action.

#### DISCUSSION

Beginning with SB 45 (Kopp) in 1997, regional and county transportation agencies, specifically Regional Transportation Planning Agencies (RTPAs), were given authority for programming county shares of State Transportation Improvement Program (STIP) funding though a California Transportation Commission (CTC) led process. In this process, each RTPA is tasked with preparing a Regional Transportation Improvement Program (RTIP) consistent with CTC's STIP Guidelines to allocate these funds based on a statutorily defined formula incorporating population (75%) and highway lane miles (25%) as the basis for "county shares."

Sacramento Area Council of Governments (SACOG) serves as the RTPA for Sacramento, Sutter, Yolo, and Yuba counties. SACOG submits its RTIP every two years, programming the county shares of STIP funds for these counties using a pooled competitive approach.

In February 2024, SACOG revamped its STIP funding approach to include both a competitive regional program and individual intra-county competitive programs with a separate call for projects from the federal funding programs. Then in February 2025, SACOG approved a funding estimate for the 2025 Four-County STIP Program, with 90% of each county's share allocated to individual intra-county competitive funding programs, as well as a call for projects. See Table 1, below.

At the end of 2024, Yolo County began considering a collectively beneficial approach to the upcoming 2025 Four-County STIP Program with approximately \$5.4 million available for the county. The approach would be to partner through an MOU utilizing formulas to allocate STIP funding across eligible agencies to develop and submit a competitive package of projects to SACOG. This approach would improve the certainty of the funding amounts at the agency level and SACOG has expressed a willingness to support this approach by evaluating projects for competitiveness through a pre-application process. This approach also complements the upcoming competitive federal funding programs which will allow each agency to obtain additional federal funding.

In January 2025, Sacramento Transportation Authority (STA) sent information about Yolo County's approach to several local agencies for consideration. After some positive feedback, STA held a Professional Advisory Group (PAG) meeting in coordination with SACOG and local agencies on February 20th to introduce the approach to a larger group of agencies along with a concept of how it could work for Sacramento County reflecting 22.5% for transit and rail projects and the remaining 77.5% for roads and active transportation projects using a geographic suballocation approach for the County and Cities using the Measure A formula of 75% population and 25% lane miles. The PAG was supportive of bringing this concept forward to the STA Governing Board.

In March, the STA Governing Board received a presentation on the SACOG four-county STIP funding program and approved the proposed strategy for a collectively beneficial MOU approach that enhances funding predictability while maintaining regional competitiveness.

Since the March STA Governing Board meeting, STA has received comments from several agencies on the conceptual draft MOU. An updated version of the MOU, which incorporates the comments received, is attached.

SacRT Staff recommends that the Board authorize the General Manager/CEO to execute the MOU regarding coordination of STIP funding applications and communication on the federal funding program (Sacramento County) in substantially the form presented.

#### RESULT OF RECOMMENDED ACTION

Approving Contract Change Order (CCO) No. 11 to the Contract for Watt/I-80 Transit Center Improvements (Transit Center) with Thompson Builders Corporation (Thompson) will allow Thompson to relocate Sacramento County's unforeseen fiber optic line and connect it to the service pedestals.

#### FISCAL IMPACT

CCO No. 11 will add \$159,816.00 to the not-to-exceed amount for the Contract. Contractor will be paid the lump-sum amount \$187,226.00 for the relocation of the County fiber cable due to unforeseen utility conflict. That amount is expected to be partially offset by reductions in the quantity of drainage work required, which will be deducted on a unit-price basis. This CCO will be funded with a combination of FY20 Solutions for Congested Corridors Program (SCCP), FY22 Federal CMAQ, and FY22 Federal 5307 funds.

#### DISCUSSION

The current Transit Center is one of the busiest transfer centers in the Sacramento region. It has been prone to safety and security challenges because of the location and design, situated both above and below major roadways, with steep enclosed stairwells, and in a high-crime area. The scope of the construction contract includes reconstructing the Transit Center's bus stop waiting areas on Watt Avenue; replacing the stair structures; widening the sidewalks along the Watt Avenue overpass; incorporating improved bike access along the overpass; improving pedestrian access under Watt Avenue from the northbound bus stop to the light rail station; modifying the freeway off-ramps for improved pedestrian access; adding/updating lighting, signage, site furnishings, and fencing; and updating the operator restroom and breakroom.

The Board delegated authority for the GM/CEO to award a construction contract on October 23, 2023, and a construction contract was executed with Thompson Builders Corporation (Contractor) on January 26, 2024. Notice to Proceed was issued on May 9, 2024.

The Contract scope included demolition of the center median on the top of the Watt Avenue bridge and required Contractor to protect and maintain Sacramento County's traffic signal interconnect system located at the center median of Watt Avenue. During the Underground Service Alert (USA) utility location marking process, it was determined that in addition to the interconnect (copper coaxial cable), there is also a fiber optic line owned by Sacramento County. The County fiber optic line was not shown in as-built or record drawing documentation known to SacRT, the designer Mark Thomas & Company (MTCo), or the County CMID Inspector assigned to the project; nor was it marked up or noted by the County during its reviews of the project plan set.

As part of CCO No. 5, SacRT granted Contractor a compensable time extension for this differing site condition, but the ultimate plan for relocation of the fiber optic cable was deferred while SacRT's design contractor prepared updated Plan sheets that reflect the relocation.

The existing fiber optic line lays underneath the median, is unprotected, and is not in a conduit. For Thompson to complete the contractual scope of work, the fiber line must be relocated, and the relocated fiber must be cut-over and operational prior to the demolition of the center median.

The new design for the relocated fiber optic line will also affect the connections to the service pedestals at both eastbound and westbound off-ramps from I-80. The pathway of

the relocated fiber optic line will also conflict with a proposed drain inlet and storm drain pipe at the Watt Avenue on-ramp to Auburn Boulevard, which Contractor must now relocate to an existing drain inlet.

#### RESULT OF RECOMMENDED ACTION

The proposed Resolution will declare an operator safety emergency and delegate authority to the General Manager/CEO, or their designee, to authorize the procurement of retrofit bus barriers to support the emergency condition due to the increased severity of assaults on operators.

#### FISCAL IMPACT


Funding in the amount of \$1,034,522.50, which is inclusive of sales tax, is needed to purchase parts to retrofit 162 forty-foot buses with operator barriers. Staff has secured \$544,289.00 in Measure A funds and is actively pursuing additional funding to cover the balance. SacRT staff will complete the installation in-house. The remaining bus fleet is scheduled for replacement over the next two years and will be equipped with barriers at the time of purchase.

#### DISCUSSION

Bus operator assaults have increased nationwide, and SacRT is experiencing similar trends. According to the National Transit Database (NTD), from 2014 to 2024, there was an average of 405 assaults against transit workers that occurred annually in transit vehicles. Alarmingly, major assaults on transit workers, which the FTA defines as an event resulting in a fatality or injury requiring medical transport, tripled between 2014 and 2024. In fact, major assaults alone on transit workers went up 86% from just 2018 to 2024. Despite current efforts to eliminate bus operator assaults through strategies such as de-escalation training, video monitoring, and campaigns to respect operators, assaults are still rapidly increasing.

Under Public Utilities Code section 102222(a), SacRT contracts for the purchase of supplies, equipment, and materials in excess of one hundred twenty-five thousand dollars (\$125,000) must be awarded to the lowest responsive and responsible bidder or, in SacRT's discretion, to the responsive and responsible bidder that submitted a proposal that provides the best value on the basis of the factors identified in the solicitation. With the identification of a prototype to fully enclose the operator seating area, a Board declaration that an emergency situation has arisen resulting in a need to secure bus barrier equipment to protect SacRT's bus operators without conducting a formal solicitation as authorized under Public Utilities Code section 102222(b) is required to accelerate purchase and installation of the barriers to protect the health and safety of SacRT's bus operators.

#### Implemented Strategies to Prevent Operator Assaults

SacRT staff has been proactive in our efforts in the research of best practices and analysis of data to implement safety strategies to protect our employees. In collaboration with its Employee Assault Mitigation Task Force, SacRT has been implementing prevention strategies to reduce the risk of safety incidents and create a safer environment for all SacRT employees to safely perform their jobs:

- SacRT buses have up to nine on-board cameras and a DVR
- SacRT buses have emergency buttons



- Clear signage will be posted about legal penalties for assaults on operators ("Let's Respect Operators...injuring an operator is punishable by up to three years in prison or up to 10,000 fine, or both." Penal Code 243.3")
- Operators are currently receiving de-escalation training
- SacRT has a "See Something, Say Something" campaign and a "Respect the Ride, Respect the Employee" campaign has recently launched highlighting how to treat operators.

#### Retrofit Barrier Background

SacRT staff worked closely with the Amalgamated Transit Union and bus operators to test three types of bus barriers. After a trial period, SacRT operators represented by ATU chose the Arrow Barrier.

On the SacRT bus system, aggravated assaults on bus operators increased by a factor of 4 between 2023 and 2024, and battery on bus operators doubled during the same period (see Chart 1). This recent trend is extremely alarming and must be addressed immediately. Data analysis revealed that 50% of incidents since 2023 occurred due to the assailant being able to access the operator.



The primary methods for attacks on operators have consistently been physical assaults with hands or spitting, with assailants exploiting the unprotected Operator's area to commit the act.

#### Current Impact on SacRT

SacRT has experienced an escalation in the type and severity of violent operator assaults over the last few years. These incidents have occurred with no provocation or warning and have created an environment of increased risk and trauma as assailants are resorting to the use of violence. The sudden, unexpected increase in the violent nature of bus operator assaults has resulted in an emergency procurement condition, giving rise to the need to immediately procure barriers to retrofit the current buses with an enclosed barrier to protect the health and safety of bus operators as soon as possible.

Safety is of the utmost importance to SacRT, and it is imperative that bus operators are protected from assaults that have been increasing nationwide. Bus operators face disproportionate safety risks as frontline staff. Their safety is necessary to ensure dependable public transportation for community members who rely on transit. The safety of bus operators will be enhanced with the streamlined procurement of the supplies necessary for the installation of fully enclosed-tempered glass protective barriers that provide a significantly higher level of protection than not having any barrier in place to separate the operator from the public. This action to authorize procurement in an expedited manner will help to ensure the safety and well-being of SacRT's bus operators.

#### Next Steps

This emergency authorization will allow procurement to purchase bus barriers to be installed on all of SacRT's buses. Initial deployment of the new barriers will be on buses that operate on lines that have experienced the greatest number of operator assaults within the past year.

Upon Board approval, Staff will initiate the procurement of equipment and supplies to install enhanced operator barriers for the approval of the General Manager/CEO. Procurement staff will review to determine that the proposed equipment prices are fair and reasonable and Finance staff will determine that funding is available before the Contract is executed.

THAT, pursuant to Public Utilities Code section 102222(b), the Board declares that an emergency condition exists that could result in imminent harm to bus operations personnel, property, and essential public services, which justifies the suspension of competitive bidding to purchase the bus retrofit barriers required to mitigate the emergency.

THAT, the Board hereby suspends competitive bidding for the purchase of bus retrofit barriers and hereby delegates authority to the General Manager/CEO or his designee to execute contracts that would otherwise be in excess of his authority under the Procurement Ordinance to the extent necessary to facilitate purchase and installation of bus barriers up to a maximum aggregate amount of \$951,285.06, plus applicable sales tax.

THAT, the foregoing delegation will expire, without further action by the Board, as of April 30, 2028.

#### DISCUSSION

Title III of SacRT's Administrative Code, adopted by the Board, provides for the creation of an Ad Hoc Committee. The Chair is authorized to appoint all Ad Hoc Committees (§3.1.8.1). Title III requires that meetings of Ad Hoc Committees must be open to the public, except for meetings which would be eligible for closed sessions under the Brown Act. If less than a quorum of the Board is appointed to serve on Ad Hoc Committee, no notice need be given other that the posting of a notice of the time and place of such committee meetings on a publicly accessible bulletin board at the offices of the District, which is located at 1400 29<sup>th</sup> Street, Sacramento, California (§3.1.8.3).

#### FISCAL IMPACT

CCO Nos. 1.1 and CCO No. 7 were fully funded with state and federal funds.

#### DISCUSSION

The City of Sacramento (City), in partnership with the Sacramento Housing and Redevelopment Agency (SHRA) and Sacramento Regional Transit District (SacRT), proposes implementation of the Twin Rivers Transit-Oriented Development and Light Rail Station Project (Project). The Project will develop a mixed-income, mixed-use community comprising of 218 replacement public housing units, 281 new market-rate rental and Low-Income Housing Tax Credit (LIHTC) units, a realigned internal street network, green open space, and other community amenities on two noncontiguous properties in close proximity to one another, totaling approximately 24.2 acres that currently includes public housing and undeveloped land. The Project includes construction and operation of the proposed SacRT Dos Rios Light Rail Station on the existing SacRT light rail Blue Line and adjacent to North 12th Street. The new Dos Rios Light Rail Station will include track realignment, signaling modifications, system upgrades, and construction of the new station.

On June 10, 2024, the Board conditionally awarded a Contract to DMZ Builders for an amount not to exceed \$27,417,581. The Notice to Proceed (NTP) was issued on August 6, 2024.

Since NTP was issued, the General Manager/CEO or his designee has issued several CCOs due to unanticipated issues. Section 1.506 of SacRT's Procurement Ordinance

2022-12-001 establishes the General Manager's authority to issue Change Orders for Public Works Contracts and states that:

"For CONTRACTS originally awarded for a price of \$10,000,000 or more, the GENERAL MANAGER has authority to issue change orders if the sum of all such change orders for any single CONTRACT does not exceed the following percentages of the original CONTRACT amount: 10% of the first \$1,000,000, plus 8% of the next \$9,000,000, plus 6% of the balance."

The Procurement Ordinance also states that "notwithstanding the foregoing, any single change order that exceeds \$150,000.00 requires BOARD approval."

However, despite this limitation, under Procurement Ordinance Section 1.506(F)(1):

"The GENERAL MANAGER has authority to issue change orders in such sums as may reasonably be necessary if the GENERAL MANAGER determines, in writing, that a change order is required to: 1. Prevent interruption of the work which would result in a substantial increase in cost to SACRT..."

When such an exception is taken, "the GENERAL MANAGER must report such action to the BOARD as soon as reasonably possible but in no event more than 30 days after the action is taken."

The Contract scope includes the removal and disposal of hazardous material that are tested and classified as Type Z-1 (Aerially Deposited Lead) material. However, the quantity of Type Z-1 (Aerially Deposited Lead) soil material was significantly underestimated in the Bid Documents.

The Bid Documents assumed that approximately 4,015 cubic yards of material would be excavated for roadway and track work and that, of that total, 700 yards would require special handling.

To date, an additional 1,211 cubic yards above and beyond the initial estimated quantity have been excavated, stockpiled, and tested to be Type Z-1 (Aerially Deposited Lead) requiring special handling. It is anticipated that additional soil will be excavated that requires special handling.

It took several months to characterize the excavated soil, which has been stored in stockpiles on the Sacramento Housing and Redevelopment Agency property. To make room for additional soil and avoid an interruption to the ongoing work, on April 2, 2025, the General Manager issued an amendment to CCO No. 1 for removal and disposal of hazardous material tested as Type Z-1 (Aerially Deposited Lead) material. The amendment brought the total for CCO No. 1 to \$157,250.00, which exceeded the General Manager's typical authority of \$150,000.00.required by the Procurement Ordinance, the General Manager is reporting back on this action.

Unfortunately, even with the removal of a portion of the stockpiled material, it became necessary to authorize additional stockpile removal to allow work to proceed. CCO No. 7 was issued April 25, 2025 to dispose of additional hazardous material tested and classified as Type Z-1 (Aerially Deposited Lead) material for track and roadway excavation billed up to February 2025.

#### Tap2Ride: A Faster, Easier Way to Pay for Your Ride

SacRT's Tap2Ride program offers a contactless fare payment system designed to simplify your transit experience. Riders can enjoy a faster, more convenient way to pay for bus, light rail, and paratransit services.

To ensure a smooth implementation, the Tap2Ride program is rolling out in two phases:

#### Phase 1: Available Now

Tap2Ride devices are available on buses and SacRT GO paratransit vehicles.

- Buses and SacRT GO Paratransit Services: Riders can use contactless debit or credit cards and mobile wallets on Tap2Ride devices installed on buses and SacRT GO shuttles to pay fares and transfer seamlessly between buses.
- Light Rail Stations: Contactless fare payment is available at fare vending machines located at all light rail stations. However, during this phase, fare transfer benefits between bus and light rail (90-minute window, 25-cent transfer fee, and unlimited rides between bus and light rail for the day) are not valid using contactless payment.

#### Phase 2: Expected in Late 2025

• New Tap2Ride Devices at Light Rail Stations: The program will expand to include new contactless fare payment options at all light rail stations. Once this phase is complete, riders will be able to use contactless payment to transfer seamlessly between buses and light rail trains.

#### How Tap2Ride Works

- On Fixed-Route Buses and SacRT GO Paratransit Services: Tap your contactless debit or credit card or mobile wallet (Visa, Mastercard, Discover, and American Express) on a Tap2Ride device as you board.
- On Light Rail: Use fare vending machines at light rail stations to pay with your contactless card or mobile wallet (Phase 1). Once Phase 2 launches, Tap2Ride will be a option at stations, allowing full integration for transfers.

Note: To transfer between buses, be sure to use the same contactless payment method—the same card or smart device—throughout your trip.

#### Discounted Fares for Eligible Riders

Tap2Ride offers built-in support for fare discounts, making transit more affordable accessible for:

- Seniors (65+ years old)
- Veterans
- Persons with Disabilities (Medicare cardholders)

Discounts are securely linked to your contactless payment card through the California Integrated Travel Project (Cal-ITP) web tool/app. This process eliminates the need for inperson verification, so you can focus on your journey. To check discount fare eligibility, click here.

#### Blue Line Service Disruption May 3-4

SacRT is making steady progress on modernizing the light rail system to welcome the new low-floor light rail vehicles on the Blue Line. As part of the ongoing platform construction project along the Blue Line, Alkali Flat/La Valentina Station will temporarily close for work on the weekend of Saturday, May 3 and Sunday, May 4, 2025.

To accommodate this work, a bus bridge will be in place between Globe and 10<sup>th</sup> & K stations, with K Street closed to vehicles between 8th and 12th streets.

## Low-Floor Station Modification Project

SacRT is preparing to enter the next stage of station platform construction on the Blue Line to accommodate the new low-floor light rail vehicles. Before that work begins, there will be a few more service disruptions at Globe and Alkali Flat Stations in April and May. During this time, the contractor will be installing Mini-High Shelters at Globe and installing detectable warning services at both stations.

Although the timeline for the next phase, which will include modifications to the remaining Blue Line stations and further upgrades to Gold Line stations, is still being developed it is anticipated that construction will restart in early 2026.

## Monthly RTPS Social Worker Data Report

On February 6<sup>th</sup>, 2025 Officer Pangelinan & SW Rose attended a meeting focused on Critical Infrastructure in the unincorporated area of Sacramento County where several entities meet to discuss the impact of unhoused persons. SW Rose provided information on outreach, collaboration with RTPS, education of Sac RT critical infrastructures areas including the tracks & access roads, and how large encampments have impacted these areas.

On February 7<sup>th</sup>, 2025, Social Worker Rose established a new partnership with Joan Viteri Memorial Clinic. The clinic was founded in memory of Joan Viteri, a resident of the Oak Park neighborhood in Sacramento who died as a result of a treatable abscess. Fearing judgement from the medical community because of the stigma tied to intravenous drug use, she was unable to obtain the medical care she needed. Together with Harm Reduction Services and the Gender Health Center, JVMC strives to prevent such tragic and unnecessary deaths among stigmatized populations in the Oak Park community. Equipped with specific resources to treat individuals who use intravenous drugs, individuals who work in the sex trade, and members of the LGBTQ community, JVMC treats all patients with dignity and respect. SW Rose will utilize this new partnership to promote health care amongst the clientele she serves on a daily basis.

Social Worker Rose established a new partnership with Sacramento Regional Conservation Corps to better serve unhoused young adults looking to develop job skills and work experience. The Sacramento Regional Conservation Corps (SRCC) is a non-profit organization that provides an opportunity for 18-26 year-old young adults to acquire educational achievement and paid work experience. The SRCC improves communities in the Sacramento region by engaging young adults in a values-based approach to defining success. SRCC provides opportunity for young people to realize their potential in their educational career and life through community building, technical skills training, and job placement services. SRCC creates highly qualified employees that contribute to the community and a sustainable future.

On February 28<sup>th</sup>, 2025, Social Worker Rose attended the ACCESS California's Annual Statewide Conference to learn about a unique analysis for impacted communities and stakeholders, which included presenters with subject matter knowledge of systems from perspectives of counties, providers, and individuals with lived expertise with behavioral health intersections.
